NAVJEEVAN FOUNDATION AND NIM HAVE REACHED AN UNDERSTANDING AS FOLLOWS:

1. OBJECTIVE

- The Parties will endeavor to strengthen, promote and develop co-operation between the Parties on the basis of equality and mutual benefit.
- The MOU is being signed on the prospect that both the organizations collaborate on Social activities and ensures co-operation between the two organizations.

2. AREAS OF CO-OPERATION

2.1 Each Party will endeavor to take the necessary steps to encourage and promote co-operation in the following areas:

- a) Working for the welfare of empowerment of women and youth of the marginalized and under - developed sections;
- b) Sensitizing the society towards the rampant exploitation of such weaker sectors either in employment or in trafficking;
- c) Creating a collaborative environment for the development of deprived section of the society with special emphasized on the youth & women in difficult situation in the existing socio- political scenario;
- d) Creating a conducive environment for the betterment and development of the deprived section of society;
- e) Mobilizing the community to assert their rights and encouraging a participatory approach to development;
- f) Any other Social activities mutually planned in fields for upliftment of deprived and weaker section.

3. FINANCIAL ARRANGEMENTS

- 3.1 This MoU will not give rise to any financial obligation by one Party to the other.
- 3.2 Each party will bear its own cost and expenses in the implementation of this MoU.

4. CONFIDENTIALITY

Unless otherwise agreed to in advance and in writing by both the parties, no party can make use of the confidential information for any purpose whatsoever other than the performance of the services or disclose the confidential information to any third party.

5. ENTRY INTO EFFECT AND DURATION

- 7.1 This MoU will come into effect on the date of signing and will remain in effect for a period of Five (5) years.
- 7.2 This MoU may be extended for a further period as may be agreed in writing by the Parties.

6. REVISION, VARIATION AND AMENDMENT

- 8.1 Any Party may request in writing a revision, variation or amendment of this MoU.
- 8.2 Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MoU.
- 8.3 Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.
