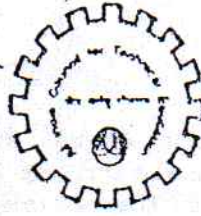

Above conditions should be fulfilled latest by 10th October, 1996.

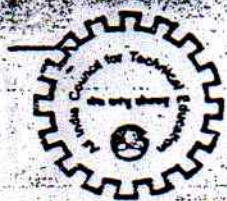

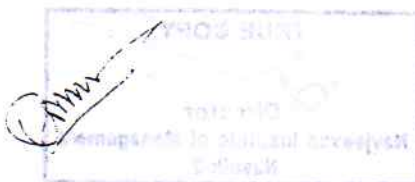

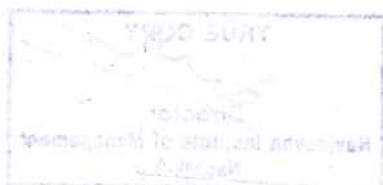
